# If you stand up for fundamental rights, you are a human rights defender

Regardless of whether you are a journalist, a farmer, a teacher, a committed citizen, a student, or a lawyer, regardless of your age, your background, your sexual orientation, your gender identity and expression, and of your sexuality, regardless of whether you defend the rights of people with disabilities, the environment, democracy, the rights of your land or your community, or any other rights, you have the right not to be persecuted, attacked, or threatened.

You have the right to no retaliation against you, your community, or your family. You have the right to be protected, empowered, enabled, and accompanied. You have the right to defend rights.

If you are at risk as a result of your human rights work, ProtectDefenders.eu is here to support you.

ProtectDefenders.eu delivers hands-on assistance to human rights defenders and communities under threat. Our programmes can be combined to provide comprehensive solutions for your protection needs.

Our programmes are flexible and tailored to respond to the specific needs of women human rights defenders, as well as LGBTI people, in all their diversity.

We seek to support and reach out to those defenders who are more isolated and less connected, and those who are particularly targeted.



## Emergency support

We deliver grants for urgent protection measures – including medical, legal, psychosocial, or family support; digital, physical, or office protection; urgent relocation, etc. Each case is different, so are the grants.



## Support for local organisations and groups

We support organisations and communities to help advance their work to defend human rights, through small grants aimed at developing innovative projects or consolidating capacities.



## Temporary relocation

ProtectDefenders.eu enables the temporary relocation away from risk for human rights defenders by providing support to host entities giving individualised and holistic support to human rights defenders at risk, and to their families.



## Shelter initiatives

We promote the creation and reinforcement of shelters for regional or in-country temporary relocation of human rights defenders and their families, through funding and technical support.

We also coordinate the **European Union Temporary Relocation Platform (EUTRP)**, which brings together entities from across the globe to exchange expertise in the field of defender relocation.



## Field monitoring and advocacy

We monitor the situation of at-risk defenders on-site and carry out advocacy work to trigger adequate responses to their cases. Together, we call for an environment conducive to the defence of rights.

## Training, capacity development, and accompaniment

We work with organisations and defenders to develop their skills and capacity to pursue their human rights work more safely, and we provide long-term support to communities defending rights in the most oppressive contexts.
